## BEER SPA REGULATIONS

1. *The right to use the beer spa independently is granted to clients aged 18 and above.*
2. *The duration of a beer bath is 45 minutes.*
3. *If the time limit is exceeded, the receptionist has the right to ask clients to leave the beer spa room.*
4. *A maximum of 2 people may stay in the beer spa room at the same time.*
5. *The water temperature in the wooden tubs is approximately 37–38°C.*
6. *The equipment of the beer spa – bathrobes, towels, and beer mugs – is the property of the hotel and must be returned. The client is responsible for any damage or loss.*
7. *Beer spa access is available from 9:00 AM to 9:00 PM.*
8. *Beer bath reservations can be made at the hotel reception.*
9. *Every person uses the beer spa at their own risk and responsibility.*
10. *Only healthy individuals may use the beer spa; a medical consultation is recommended.*
11. *The following individuals are particularly prohibited from using the beer spa:*
  - ❖ *pregnant women*
  - ❖ *minors*
  - ❖ *people with elevated body temperature*
  - ❖ *people with inflammatory conditions of internal organs, such as heart or vascular diseases*
  - ❖ *people with cancer*
  - ❖ *people with spasmodic diseases*
  - ❖ *people with allergies or skin diseases*
12. *Pouring beer into the wooden tubs is strictly forbidden and will result in a financial penalty depending on the amount of beer used.*
13. *The following are prohibited:*
  - ❖ *jumping into the tubs*
  - ❖ *pouring beer into the tubs*
  - ❖ *taking beer outside the beer spa room*
  - ❖ *spilling water from the tubs*
  - ❖ *running inside the spa room*
  - ❖ *bringing in unauthorized persons or animals*
  - ❖ *taking actions that may pose any threat to other users or oneself*
  - ❖ *smoking*
  - ❖ *independently adding water or using the disinfection equipment*
14. *Beer spas are to be used solely for wellness purposes. It is forbidden to damage or pollute the equipment.*
15. *Do not use the beer spa after a heavy meal.*
16. *Please report any irregularities in equipment functioning to the hotel reception.*
17. *It is forbidden to bring sharp objects, personal equipment, or to consume your own food and alcohol in the spa.*
18. *Guests must behave appropriately and respectfully during their stay in the spa.*
19. *Guests showing signs of alcohol, drugs, or performance-enhancing substance use before the bath will be asked to leave.*
20. *Hotel Szybark and its staff are not responsible for items left in the beer spa.*
21. *Clients are fully responsible for any damage caused in the spa room or its surroundings.*
22. *Any defects or missing items must be reported immediately to the reception; otherwise, the current guests will be held responsible.*

## BEER SPA REGULATIONS

- 23. *Hotel Szymbark and its staff are not liable for accidents resulting from non-compliance with the rules or safety instructions.*
- 24. *In case of feeling unwell, leave the beer spa room immediately and call for help.*
- 25. *Every client is obliged to read and follow these regulations.*
- 26. *Hotel staff has the right to remove guests who do not comply with the regulations.*
